PURPOSE :

1. Provide a sound testing program that allows a variety of goat producers to participate.
2. Promote the value of performance testing of meat goats in Pennsylvania.
3. Provide a common test for evaluating rate of gain, structural soundness, and estimated carcass merit.
4. To identify bucks which excel in growth and meat production characteristics.

SPONSOR :

The Pennsylvania Department of Agriculture, in cooperation with Penn State's Department of Dairy and Animal Science.

SPECIES ADVISORY COMMITTEE :

Anyone who participates in this year's tests will automatically become members of this year's Species Advisory Committee and will begin their duties about May 1. Chairman of the Technical Advisory Committee will chair this committee and meetings will be called as needed. Participants are encouraged to forward suggestions or concerns in writing to the chairman or to the assistant director of the LEC.

TECHNICAL ADVISORY COMMITTEE :

Representation on this committee will include Penn State animal science faculty members involved in small ruminant teaching, research, and/or extension (Dr. Harold W. Harpster, and Mr. Richard Kuzemchak), the attending veterinarian (or designee, Dr. Lester C. Griel, Jr.), a representative of The Pennsylvania Department of Agriculture (Mr. Ron Miller), the assistant director of the Livestock Evaluation Center (Mr. Greg Hubbard), and three goat producers selected for three-year terms:

Keith Wadel (term expires 10-1-11)

Tom Miller (term expires 10-1-11)

Members of the Technical Advisory Committee will be listed in the sale catalog.

SALE COMMITTEE :

The combined Species and Technical Committees will make up the basic Sale Committee. A smaller group consisting of two or three individuals from the technical committee and five or six test participants appointed by the co-chairmen of the Executive Committee will be responsible for making and carrying out the final decisions on all sale details.

ELIGIBILITY REQUIREMENTS FOR ENTRY :

1. The test is open to purebred and papered percentage bucks born between September 1, 2010 and February 28, 2011. (Sep.1 – Dec 31. born bucks = Senior bucks. Jan and Feb born bucks, = junior bucks.)

Animals must be identified to meet Current Federal Scrapie Regulations.

2. Bucks must be weaned at least two (2) weeks prior to entry date and weigh at least 30 pounds upon delivery.
3. Bucks must have a recorded birth date and their sire must be known and documented.
4. Bucks must be free of obvious structural or reproductive abnormalities. This is a combination of structural correctness, mouth, frame type, natural muscling, and breed type.
5. Bucks must arrive at the Center with feet recently trimmed, with no evidence of any foot disease.
6. All bucks must be accompanied by a veterinarian’s statement that required vaccinations, at least one vaccination of CDT (C. perfringens with Tetanus) and/or tests have been done within the designated time, that the buck is in good health and apparently free of infectious and contagious diseases and that it originates from a herd from which no infectious and/or contagious diseases including scrapie, OPP and Johne’s have been diagnosed within the past 12 months.

DELIVERY GUIDELINES:

**BUCKS MUST WEIGH AT LEAST 30 POUNDS UPON DELIVERY
OR
HAVE A MINIMUM WT/DAY OF AGE .35 LBS./DAY GAIN
UPON DELIVERY, WHICHEVER IS GREATER**

NOMINATION PROCEDURE :

1. Nomination forms must be received at the LEC according to the announced timetable. A nomination fee of \$20 must accompany each nomination form. Entry fee for bucks not accepted due to insufficient pen space and/or bucks that do not meet the entry requirements at the LEC will be refunded.
2. After a producer is notified that his nomination has been accepted, cancellation of entry other than not meeting entry requirements results in forfeiture of the nomination fee.

NOMINATION ACCEPTANCE PROCEDURE :

1. Nominations will be accepted from January 1 through March 15, 2011. Postmarks will determine eligibility.
2. First choice will be given to Pennsylvania breeders.
3. In the event all pen space is not utilized by Pennsylvania breeders, out-of-state nominations will be accepted.
4. After nominations are accepted, there will be no further differentiation between Pennsylvania breeders and out-of-state breeders.
5. Preference will be given to those who have participated in previous performance tests.

DATA COLLECTION :

Bucks will be weighed every 14 days and a progress report will be sent to the owner and other interested persons at least every other period. Other factors evaluated will include scrotal circumference, estimated loin eye area, daily gain, etc.

HEALTH AND VETERINARY CARE :

1. Health of the bucks will be under the supervision of the attending veterinarian.
2. Appropriate metaphylaxis may be administered for pulmonary disease if deemed necessary in the judgment of the attending veterinarian.
3. During the adjustment period, all bucks will be treated for the control of internal and external parasites and vaccinated for enterotoxemia, sore mouth, and tetanus as needed.
4. All bucks will have their feet trimmed by a professional foot trimmer at the midpoint of the test and again at the end of the test. Additional foot trimming on individual bucks will be performed as necessary.
5. Any buck deemed clinically unsound during the test will be removed from the test at the owner's expense. This decision will be made by the LEC Station Manager and the attending Veterinarian.
6. All bucks will receive a physical examination for breeding soundness, at the end of the test.
7. Bucks will be monitored routinely for internal parasites using fecal egg counts.

CARE AND MANAGEMENT :

1. Bucks will be penned in weight groups as uniformly as possible.
2. Feed, water and condition of all animals will be checked at least twice daily.
3. Bucks will have free-choice access to a commercial concentrate diet of at least 16% protein. A coccidiostat is given through the feed at recommended levels. Ammonium chloride (1%) is added as a preventive against urinary calculi formation.
4. A grass-alfalfa mixed hay will be fed free choice.
5. Also, the Technical Committee and the veterinarian may, from time-to-time, make other adjustments to the ration which they feel is in the best interest of the test.
6. Ration analysis will be done as changes occur in the ration. All feed batches will be tested upon delivery to the facility to ensure that the feed contains less than 35ppm of copper for safe feeding of goats.

RETURN OF BUCK :

Bucks may be returned at any time to the owner, at the owner's expense, for any reason deemed necessary by the technical or species committee. However, no buck will be removed from test

and/or LEC without first having approval from the LEC Station Manager and attending Veterinarian. Some reasons for return might be:

- Health (including chronic bloaters)
- Disposition
- Lack of valid identification
- Buck classified as potential non-breeder
- No Sale
- Any reason deemed necessary by the LEC Assistant Director and/or the attending Veterinarian.

LIABILITY :

The breeder retains ownership of his buck(s) while on test at the LEC. However, the breeder waives any right to press claims of any type against LEC supervisors and employees, and will sign a testing agreement that he assumes full responsibility. The cost of insurance is included in the testing charges to be paid by the owner. Owners who lose bucks during the testing period will be paid an amount equal to the market value of a medium buck as quoted at New Holland the week the loss occurred, minus testing costs incurred to that date.

PERFORMANCE TEST SALE :

1. Sale date is August 6, 2011, and will include an Invitational Doe Sale.
2. An index ratio will be used to rank the bucks at the conclusion of the test to determine the sale order for the bucks within their respective breed groups: Senior fullbloods, Junior fullbloods, Senior percentage, and Junior percentage. Each breed group will sell separately, in the order listed previously. All bucks eligible for sale must be offered for sale.
3. Approximately the top 75% within any breed and/or breed group will sell. However, the Sale Committee will determine the actual number offered for sale.
4. **All registration papers must be provided to the LEC Station Manager no later than July 5, 2011, in order to be eligible to sell.**
5. The number of bucks offered for sale by an individual consignor may be limited by the sale Committee.
6. **All Bucks and Does offered for sale will be assessed a 10% Sales Commission on the final sale price. Bucks and Does offered for Sale which do not receive a bid will be assessed a 10% Commission on the Minimum Bid Price. Bucks and Does offered for sale which do not receive a bid will remain the possession of the breeder.**

RATING BUCKS FOR SALE :

1. All bucks will be inspected by the LEC Station Manager, attending Veterinarian, and Sale Committee for breed character and type, soundness of mouth, breeding soundness, structural correctness, etc. Depending on the severity of the fault, a buck may be eliminated from the sale regardless of performance. The Sale Committee's decision on all sale details will be final, including which bucks sell, minimum sale price, minimum index, etc.
2. ALL BUCKS MUST BE SOUND OF MOUTH [within 3 mm (approx. 0.10") over or under] IN ORDER TO SELL.
3. ALL BUCKS MUST BE SOUND OF SCROTUM [scrotal cleft of less than or equal to 5.0 cm (approx. 2.0")] IN ORDER TO SELL.
4. Bucks with unacceptable teat structure as identified in the USBGA handbook will not be offered for sale. Examples include: Fish teats and multiple fused teats.

5. An index score will be calculated for each individual based upon:
 - 40% on average daily gain
 - 20% on lifetime weight-per-day-of-age
 - 20% on area of longissimus muscle (loin) at the first lumbar site as measured by real time ultrasound adjusted by the goat's metabolic weight

$$\frac{\text{Area of longissimus muscle (loin)}}{\text{BW}^{0.75}}$$
 - 20% circumference around the widest part of hind left leg as measured with a tailor's tape adjusted by the goat's metabolic weight

$$\frac{\text{Circumference of hind left leg}}{\text{BW}^{0.75}}$$

The adjustment to metabolic body weight will give lighter goats a fair comparison of muscling to heavier goats.

The deviation from the average of the parameters measured, from the goats in the performance test will be used in the index calculation. Thus, the average index score for bucks on test will be 100. Bucks that are above average will have indices above 100 and those below average will have index scores below 100.

TESTING COSTS:

1. A \$20 (twenty dollars) nomination fee per buck will be applied toward testing cost of all bucks that are delivered. Anyone who does not deliver his/her buck(s) after they have been accepted will forfeit the nomination fee.
2. The \$20 nomination fee, plus forty (\$40) dollars is due at the time of delivery for a total of \$60 (sixty dollars) per buck.
3. If a buck dies or must be removed from test, the owner will pay all expenses incurred to that time.
4. Grain costs for each buck will be calculated by multiplying the average pen feed conversion times the actual gain (in pounds) of each buck in the pen times actual grain costs.
5. Other testing costs (hay, straw, vet bill, scanning, etc.) will be divided on a per buck basis.
6. A yardage fee of \$.08/day/buck will be charged to help offset miscellaneous testing costs such as postage, telephone and office supplies.
7. Out-of-state participants will also be charged a fee for labor and facilities which will be (approximately \$12.50/buck). Total testing costs commensurate will be determined by the LEC assistant director.
8. All sale expenses such as advertising, auctioneer, and catalogs will be determined as a percentage of the sale gross and deducted from the selling price of each buck sold.
9. No buck may be removed from the LEC until all incurred expenses are paid unless approved by the LEC Station Manager. Anyone not paying expenses will jeopardize the opportunity for future testing until all accounts are paid.
10. Final test payment or billing will be made to all test participants within 30 days of the sale providing all testing bills have been paid.
